I therefore agree that should Producer, Interviewer, or any other licensee be sued because of any comments of mine I will defend and indemnify (including paying any attorney fees) the Producer, Interviewer, or other licensee from such lawsuit. I also expressly release Producer, Interviewer, and all licensees from any claim for invasion of privacy, trade disparagement, defamation, or other claim I might have that arises out of the Film or authorized derivative works

This Release will in all respects be governed by and interpreted, construed and enforced in accordance with the laws of the state of Massachusetts without reference to conflicts of law principles of any jurisdiction, represents the entire understanding of the Parties with respect to its subject matter, and may not be amended unless mutually agreed to by both Parties in writing. I agree that any lawsuit concerning this Release, the Interview, or the Film shall only be brought in either the United States District Court, District of Massachusetts in Boston or the Suffolk or Middlesex County Superior Court of Massachusetts. I waive the right to bring lawsuit in any other court and also waive the right to object to any of the above-named courts' personal jurisdiction over me or inappropriateness or inconvenience as a forum. I waive any right to injunctive and/or other equitable relief.
